


## The Faculty of Law Successfully Organizes the First Joint Conference with the United Nations Commission on International Trade Law



The Faculty of Law, University of Macau in collaboration with the United Nations Commission on International Trade Law (UNCITRAL) Regional Office for Asia and the Pacific (RCAP) and the Comite Maritime International (CMI) jointly organized the first ever "The UNCITRAL-UM Asia-Pacific Fall Conference on Trade Development through the Harmonization of Commercial Law" during 17 and 18 October 2014. This is one of the first major conferences organized by the Faculty of Law after it moved to the new Hengqin Campus of the University of Macau during the summer of 2014.

The theme of the UNCITRAL-UM Joint Conference was inspired by the agenda of the UNCITRAL and the related areas of specialization in teaching and research at the Faculty of Law. The UNCITRAL, as one of the core legal institutions of the United Nations (UN), created the Regional Center for Asia-Pacific to promote its harmonization and unification instruments in the region with the objective of diminishing legal obstacles to global commercial transactions.



The Faculty of Law, as the oldest law school in Macau with diverse and multilingual programs and teaching staff of international background, is not only playing a very important role in promoting legal education and research in Macau law but also in fields of international, regional and comparative laws. Teaching and research in the related fields at the Faculty of law includes Masters, postgraduate and Ph.D. programs in International Business Law, European Law, and International and Comparative Law. The Conference provided a good opportunity to consolidate the cooperation between the two institutions, which started earlier with individual faculty members of the Law Faculty contributing to the works of the UNCITRAL. After the initial agreement between the two institutions, the CMI in conjunction with the UNCITRAL RCAP, joined the organization of the Conference.

Due to the distinct characteristics and focus of the organizing institutions, the Conference sought two specific types of contributions namely through invited experts and an academic call for papers. The broad theme of "Trade development through the harmonization of commercial law" was divided into six specific tracks focusing on contemporary international, regional and national developments in the related topics. The six tracks of the Conference were aligned to different thematic focus of the works of UNCITRAL namely International Commercial Arbitration and Conciliation; Investor-State Dispute Settlement and UNCITRAL Rules on Transparency; International Sale of Goods (CISG & The Hague Principles in International Commercial Contracts), International Transport of Goods and the Rotterdam Rules; Cross-Border Insolvency;

and E-Commerce Law.

In response to the call for papers, various paper proposals were received from diverse part of the world and were reviewed. The accepted papers were invited to present in the Conference in eight different sessions along with the other experts invited under the auspices of the UNCITRAL. The Conference schedule was widely publicized within the University and among various segments of the legal community in Macau, Hong Kong and other parts of the world. The promotional efforts resulted in attracting a range of interesting participants, who registered to attend the Conference and actively participated during the open discussion segments of the Conference sessions.

On 17th October 2014, the Conference was declared open by the dignitaries in a separate opening session, which was attended by a large audience and received wide press coverage. Six keynote speakers addressed the opening ceremony namely Prof. Rui Paulo da Silva Martins (the Vice Rector, University of Macau), Mr. Joao Ribeiro (the Head of UNCITRAL Regional Center for Asia-Pacific), Ms. Ng In Cheong Kim (the Chief of International Relations Division, Law Reform and International Law Bureau, Government of Macau SAR), Ms. Cristina Morais (the Head of External Economic Relations Department, Macao Economic Service, Government of Macau SAR), Mr. Jorge Neto Valente (the President of the Macau Lawyers Association), and Prof. Augusto Teixeira Garcia (the Associate Dean of Faculty of Law, University of Macau).

The Vice Rector, Prof. Martins in his opening address, reiterated the vision of the University of Macau to be an outstand-



ing and internationally recognized institution of higher learning and hailed the important initiative in organizing the Joint Conference. He distinctly pointed out to the array of speakers and the papers scheduled, comprehending contemporary developments in international trade and commercial laws. He particularly highlighted the opportunity offered by the Conference to take stock of the legal issues arising out of the 47th Session of the Commission's meeting held in New York in July 2014 and wished a productive conference to all participants. Recalling the specific strengths of the Faculty of Law and other related disciplines and faculties at the University of Macau, he expressed hope that they will continue to provide a crucial platform for international organizations like the UNCITRAL to collaborate in various academic initiatives in the future and realize their respective visions together.

Mr. Joao Ribeiro, the Head of the UNCITRAL Regional Centre for Asia and the Pacific, welcomed the Conference and invited the Macau SAR Government to further engage in local law reforms, in line with East Asia standards, for instance, by requesting the extension of application of the UN Convention on Contracts for the International Sale of Goods or by adopting legislation in line with the Model Law on Cross-Border Insolvency or with the Model Law on International Commercial Arbitration as revised in 2006. Mr. Ribeiro also suggested that Macau should consider positioning itself as "a legal hub of international trade law in the Portuguese language world, fostering cooperation, research, developing a legal and academic cluster, creating jobs and diversifying the economy".

The opening ceremony was followed by five thematic sessions on day one and three thematic sessions scheduled on the second day. Each session was assigned a Chair, who delivered the opening speech of the session and moderated the presentations of the speakers and the end of the session discussions and questions. Nearly forty international experts and scholars shared their research findings and insights on various issues of international commercial law. The speakers originated from a wide range of jurisdictions including Australia, Brazil, China, Hong Kong, Japan, Macau, Philippines, Singapore, South Korea, Sweden and the United States. The experts and scholars are affiliated to leading institutions including Comite Maritime International Asia Office, University of Tokyo, City University of Hong Kong, UNCITRAL Australia National Coordination Committee, Supreme Court of Singapore, Faculty of Law, University of Macau, Ewha Womans University, Korea, Secretariat of UNCITRAL, University of Hong Kong, Curtin University, Australia, Department of Justice of Philippines, The Hague Conference on Private International Law Asia-Pacific Office, International Arbitration Court, Hengqin, China, Australasian Dispute Resolution Centre, Australia, The Chinese University of Hong Kong, University of Canberra, Australia, Peking University School of Transnational Law, China, Jinan University, China, Beijing Normal University, China, University of Gothenburg, Sweden and other major legal institutions in Macau.

The Conference provided a rare opportunity for students, researchers, faculty members and experts both from within and outside the University to meet and share in a common platform the contemporary and

prospective developments in the field of international trade and commercial law. Dr. Muruga Perumal Ramaswamy, Associate Professor of Law and Area Coordinator of International and Comparative Law Master Program, delivered the closing address of the Conference. He highlighted some specific conclusions and recommendations arising out of different sessions and called upon the cooperating institutions to explore other potential cooperation in the future. He thanked various colleagues, students and departments in the University and the UNCITRAL and attributed the success of the Conference to their relentless support throughout the organization of the Conference. The Conference received a wide coverage in the local media and newspapers and was also reported in the relevant UN sources outside Macau.


The event had a profound significance for the students and was indeed helpful and meaningful for them to get interested in the course and broaden their view as well.

## 法學院與聯合國國際貿易法律委員會首次聯合成功舉辦研討會

2014年10月17日至18日，澳門大學法學院、聯合國國際貿易法律委員亞太區域辦事處與國際海事委員會聯合舉辦了首屆“亞太國際學術秋季研討會——貿易發展與商法協調”。這是法學院自2014年夏季遷至橫琴新校區以來，舉辦第一個的大型重要會議。

2014年10月17日，會議舉行了開幕式，得到了眾多同學、老師與媒體的關注。六位學者和官員在開幕式上進行了精彩的演講；開幕式後，會議於17日與18日先後進行了八個主題板塊。每一板塊由主席進行開場致辭、主持演講人進行演講、提出討論和問題三個部分組成。近四十位國際專家和學者在會上就國際商法問題分享了其研究成果與觀點。演講者包括了來自澳大利亞、巴西、中國、中國香港、日本、澳門、菲律賓、新加坡、韓國、瑞典、美國等眾多國家和地區的專家學者。

此次研討會為澳門大學內外的同學、研究員、專家教授與學者們提供了難得的機會在同一平臺上認識和分享國際貿易與商法領域的當代前沿發展，並得到了澳門本地與其他國家和地區媒體的廣泛關注。


