

澳門大學法學院學生參加第二屆“北仲杯”全國高校商事仲裁有獎徵文大賽，其中碩士研究生王榮國的參賽論文《論〈紐約 公約〉下英國仲裁就法律問題上訴裁定的認定與解讀》，以及王立的參賽論文《國際商事仲裁“異議權放棄條款”研究》通過初審、複審、答辯的三個環節並 最終取得優秀獎。

“北仲杯”由北京仲裁委員會（北仲）舉辦，旨在鼓勵高校法學專業學生熟悉仲裁，為更多青年將來投身仲裁事業奠定基礎。大賽面向內地和港澳台的高校法學學生公開徵文。

19位來自中國法學會、北京大學、清華大學、中國人民大學、中國政法大學、對外經濟貿易大學、外交學院、上海大學等專家組成評審組，對所有參賽論文進行了層層篩選，確定獲獎論文及獲獎級別。獲獎論文將在《北京仲裁》雜誌發表，北仲亦將為獲獎作者提供實習機會。
