The BRICS-Lawyers' Guide to Global Cooperation



- After the 9th BRICS Summit was held in Xiamen (China) on 3-5 September 2017, the book "The BRICS-Lawyers' Guide to Global Cooperation" edited by three UM Faculty of Law professors: Rostam J. Neuwirth (Full Professor), Alexandr Svetlicinii (Assistant Professor) and Denis de Castro Halis (Senior Instructor) was successfully published by Cambridge University Press in September of this year (2017).
- The book contains a total of 16 chapters written by international experts discussing a broad range of aspects of legal cooperation of the BRICS countries (Brazil, Russia, India, China and South Africa), including trade, investment, competition, intellectual property, energy, consumer protection, financial services, space exploration and legal education. Currently, it is a unique reference book suitable for academics, government officials, legal practitioners, business executives, researchers and students.

· 第九屆金磚國家峰會於 2017 年 9 月 3-5 日在廈門舉辦後,三位澳門大學法學院 教授 Rostam J. Neuwirth(全職教授)、 Alexandr Svetlicinii(助理教授)及 Denis de Castro Halis(高級講師)主 編的"金磚國家律師全球合作指南"一 書由劍橋大學出版社於 2017 年 9 月順利 出版。

本書共有16章,由國際專家撰寫以討論金磚國家(巴西、俄羅斯、印度、中國和南非)之間在廣泛領域的法律合作,包括貿易、投資、競爭、知識產權、能源、消費者保護、金融服務、空間探索和法律教育。這是一本適合學者、政府官員、法律執業者、企業高管、研究人員和學生的獨特參考書。


