◆ Seminário sobre A Função do Direito Penal na Sociedade Contemporânea

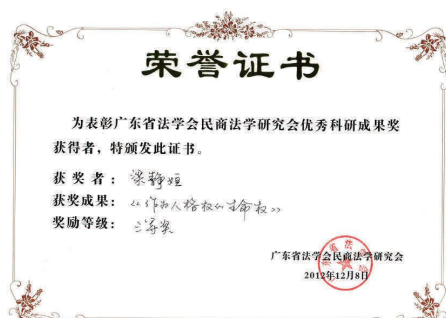
