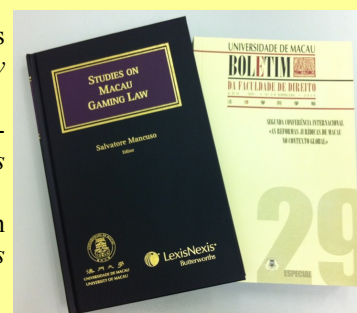

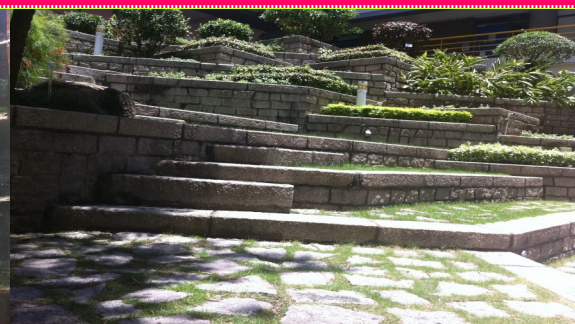

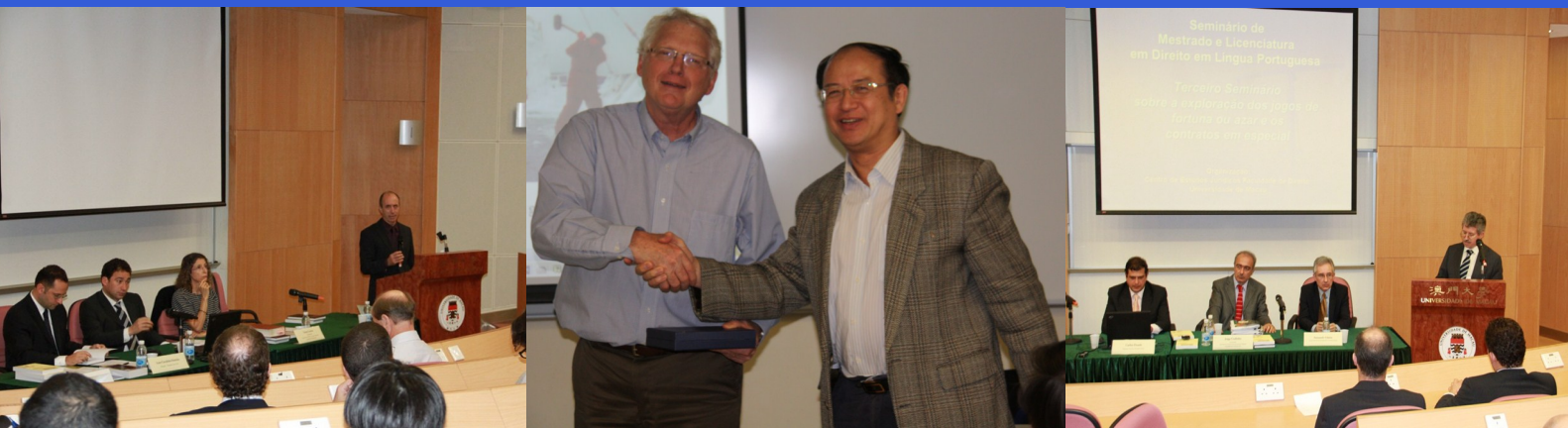

### Open Lecture Series of Faculty of Law

Faculty of Law has held an open lecture series, which already had 2 lectures until now.

**On 7 March 2012**, Prof. Guy Lefebvre, Associate Dean for Development and Graduate Studies, Faculty of Law, Université de Montréal, was invited to give a speech about “*The Vienna Sales of Goods Convention: To Take or Not to Take?*”

**On 15 March 2012**, Prof. David Vander Zwagg was invited by the Faculty of Law to deliver his lecture entitled as “*Canada, the Northwest Passage and the Future of Arctic Ocean Governance: Conflict, Cooperation, Challenges*” in J217 of University of Macau. These two lectures attracted both professors and students of Faculty of Law to attend.

### The Symposium About ‘One Country Two Systems’ Was Held In Macau

In order to commemorate the 19th anniversary of the promulgation of ‘the Basic Law of the Macao Special Administrative Region’, the symposium ‘One Country Two Systems and the Good Governance of Macao SAR’ was held on 30 March 2012 in Macau. This activity was hosted by the Association of Promotion of the Basic Law of Macao, the Research Center of the Laws of HK, Macao and Taiwan of Peking University, Legal Affairs Bureau, Civil Affairs Bureau and Bureau of Education together. At the same time, it’s co-organized by the Faculty of Law of the University of Macau, the School of Law of Macau University of Science and Technology and the Research Center of One Country Two Systems of Macao Polytechnic Institute. A lot of scholars and experts from Mainland China, Macao, Hong Kong and Taiwan attended this symposium.

Ho Lok Sum, a PhD student of the Faculty of Law, University of Macau was selected from hundreds of applicants around the world to attend the Strait Talk Hong Kong 2012 from 7 to 13 April 2012 in the University of Hong Kong.

Since 2005, under the goal of enhancing the cooperation in cross-strait issue, the Strait Talks in Brown, Berkeley, Hong Kong, and Taipei have already attracted more than 400 delegates from United States, Mainland China, Hong Kong, Macau, Taipei, and many other countries.

In the sections of Interactive Conflict Resolution, Symposium Panels, and Peace Project, the delegates need to have deep discussions on regional political, economic and social issues. This helps delegates to enhance their personal identification, broaden their visions in regional development, and improve their coordination skills in project management.

When the delegates return to their places of origin, they will continue to carry the project's influence into their positions, such as politics, law, international relations, history, sociology, journalism etc.

'Strait Talk Hong Kong 2012' offers an opportunity to Macau delegate to improve the status of Macau in participating regional issues. At the same time, it is a platform for all delegates to play a more active role in student exchange activities.
