◆ July 25, 2025 (Reception)

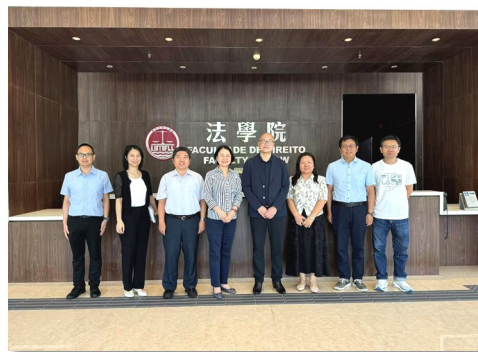

♦ July 27, 2025 (Reception)

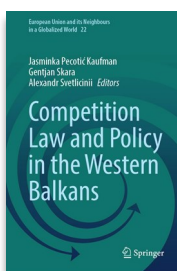
A delegation from Renmin University of China visited the Faculty of Law and was warmly received by Mr. Fan Xiaoding.
