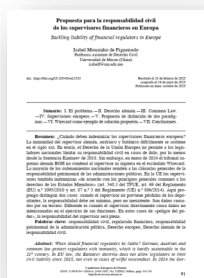

Joint Conference between University of Macau and the University of Coimbra — Public Law: International Law, Constitutional Law, and Administrative Law

The Joint Conference between University of Macau and University of Coimbra was commenced at the University of Macau (UM), bringing together over 100 experts and scholars from the Chinese mainland, Macao, and Portuguese-speaking countries to discuss cutting-edge issues in the development of the rule of law.

The two-day conference is jointly organized by UM and the University of Coimbra, with the support of UMTEC Limited and sponsorship from MGM. Themed “Public Law: International Law, Constitutional Law, and Administrative Law”, the event features three sessions focusing on international law, constitutional law, and administrative law, with presentations delivered by 14 scholars from the Chinese mainland, Macao, Portugal, Brazil, Angola, and Mozambique.

Tong Io Cheng, Dean of the UM Faculty of Law, noted that the successful implementation of the “One Country, Two Systems” policy, the harmonious coexistence of different legal systems, and the deep integration of traditional and modern legal practices have made Macao an exemplar of public law practice. He also emphasized that the mission of legal education is to produce legal professionals who are equipped with theoretical knowledge and an international perspective, and that cooperation between UM and the University of Coimbra will inject new impetus into the development of legal studies. He expressed hope that scholars participating in the conference will contribute to the development of legal theory and the practice of the rule of law.
